Shareholders who are not AMP cardholders are required to register and apply for an AMP Visa Card at any nearest AEON Credit service counters/branches before 26 June 2024.

For a shareholder who appoints two (2) proxies, only the first named proxy (Proxy 1) stated in the Proxy Form will be entitled to receive the RM50. If a proxy represents more than (1) shareholder, he/she is entitled to only one (1) credit of RM50.

The average loan size for personal financing and auto financing ranges from RM16,000 - RM25,000 with an average profit rate of 10% p.a. to 12% p.a. The effective interest rate for both segments is between 12% p.a. to 19% p.a.. The rates remained stable as compared to previous year.

The recent increase in salary of the civil servants will improve spending power and we foresee an improvement in the asset quality of this segment. The Group will continue to seek opportunities to further expand our civil servants customer base.

The Company has been gradually shifting its sales acquisition strategy to the younger segment with higher disposable income. The ongoing effort has seen an increase in new billing from this customer segment by 5% in FYE2024.

Meanwhile, we recorded a reduction in NPL from 2.89% in FYE2023 to 2.57% in FYE2024. The Company will continue to focus on portfolio management by adopting a prudent credit management approach and we expect the receivables write-off trend to stabilise in FYE2025.

In our continuing efforts to manage collection deliquency, a monitoring system has been put in place where performance KPIs are assigned to the collection agencies. We will continue to review the suitability of the KPI from time to time.

The increase in interest rates, particularly riding on the strength of the USD, has raised foreign currency borrowing costs, making them more expensive than Senior Sukuk. To optimise borrowings costs, the Company has diversified its borrowings with Sukuk Issuance.

The average funding rate for FYE2024 was 4.28%. The higher interest expenses compared to last year was due to higher borrowings which amounted of RM9.13 billion compared to RM7.82 billion in FYE2023. The higher borrowings is in line with the growth in receivables.

The Company continues to manage its borrowings portfolio based on funding requirements, market conditions, and strategic objectives to optimise borrowing cost.

AEON Credit obtained shareholders' approval to invest RM275 mil for the establishment of the digital bank business in October 2023. On 1 December 2023, the Company subscribed RM175 million ordinary shares in AEON Bank, representing a 50% equity interest in the Bank. The timing for the subscription of the remaining RM100 million investments will be based on the Bank's capital requirements and business plan. We will make an announcement when the additional shares in AEON Bank is subscribed for.

AEON Bank has received positive response from the public on its savings deposit product offering since the launch in May 2024. The deposits collected from AEON Bank will be used to fund the Bank's financing business moving forward.
